Terms and Conditions

1. Please note that whilst you are requested to sign and return this contract which is issued as a written agreement to a verbal agreement already made, failure to sign and return the document is not sufficient to cancel the agreement, therefore unless a written objection is received by The Ukaye Ukes within 14 days of the date of issue it will be assumed that the booking is confirmed.

2. The Ukaye Ukes engagement under this contract is such that they would normally be treated as self-employed for national insurance and income tax purposes by reason of being engaged under a contract for services.

3. Force Majeure No salary shall be paid for days upon which The Ukaye Ukes are unable to perform for any reason beyond the clients control such as national mourning, war, fire, strikes, or lock outs directly affecting the venue, or the order of the licensing of any public authority having jurisdiction, in any such event notice must be given to The Ukaye Ukes forthwith, failing which reasonable expenses must be paid to The Ukaye Ukes

4. Cancellation by the client For any reason other than Force Majeure every endeavour shall be made by The Ukaye Ukes to find an alternative engagement. If a reasonable alternative engagement is found at a fee less than the original contracted fee, a sum equal to the difference between the original contracted fee and the alternative contract fee shall be paid by the client to The Ukaye Ukes within 7 days following the performance date(s). If no alternative engagement is found, a sum equal to the contracted fee, shall be paid by the client to The Ukaye Ukes within 7 days following the performance date (s)

5. Cancellation by The Ukaye Ukes For any reason other than illness, The Ukaye Ukes shall be liable to the client for any reasonable costs incurred in finding a suitable replacement for the engagement

6. Illness In the event of accident or illness preventing The Ukaye Ukes from appearing, the client shall be informed at the earliest possible opportunity and if required by the client The Ukaye Ukes must provide a medical certificate forthwith The Client shall not be obliged to pay The Ukaye Ukes fee for any performance in respect of which The Ukaye Ukes are unable to perform

7. Health & Safety Where applicable the client undertakes to provide a safe working environment and where electrical equipment is in use at the venue, will ensure that regular examinations are carried out. All signatories to this contract are advised to hold public liability insurance and any relevant equipment safety documentation

8. Loss of Property It is condition of this contract that the client is not responsible for loss, nor damage to The Ukaye Ukes property unless such loss or damage is caused by the client or his/her servants or agents and /or property is in the possession or control of the client at the time of loss or damage
